Schiff Richard B. Schiff, Rear Admiral, U.S. Navy (Retired), "Rick", 71, of Oakland, MD, died Friday, September 18, 2015, at his residence. Born September 14, 1944, in Joliet, IL, he was the son of the late Leonard and Harriet (Stern) Schiff. Rick grew up mostly in Michigan and attended the University of Michigan. It was there that he met Judi Weil of Philadelphia whose love and presence he was to treasure above all else until the end. Rick and Judi married after graduation and headed off to George Washington University for law school. With the draft on, Rick decided to join the Navy's Judge Advocate General's Corps to do the four-year minimum (a wise choice since his birthday, September 14, was drawn first in the draft lottery) and return to civilian life. Four years of heroic Navy and Marine Corps clients, and he simply could not go back to the private practice of law right away; he stayed for 28 years.

# Soviets bump U.S. ships in dispute

WASHINGTON — Two Soviet warships deliberately bumped two U.S. Navy ships in international waters in the Black Sea Friday after warning they would do so, Navy officials said, adding the United States will file a protest.

The two U.S. ships were "shouldered out of the way" after the Soviets had warned, "Soviet ships have orders to prevent violations of territorial waters. I am authorized to strike your ship with one of ours," Capt. Jerry Flynn said.

The operations officer in the chief of naval operations office told a Pentagon press conference the American ships responded only by maintaining their course and speed.

Flynn and Cmdr. Rick Schiff, a Navy legal expert, said the dispute was over the "right of innocent passage" within the 12-mile territorial limit claimed by the Soviets.

The United States only recognizes a 3 mile limit, and the U.S. Navy periodically tests their right to operate within the 12 mile limit in a non-provocative way, Schiff said.

At the start of the Iraq War, though, Rick wanted to again serve Sailors and Marines getting shot at, and went back to the Department of Defense, serving as a general counsel in the intelligence community. After retirement with the world to choose from, Judi and Rick eventually settled on Garrett County, with its idiosyncratic climate, natural beauty and wonderful people.

Rear Admiral Richard B. Schiff: Assistant Judge Advocate General by Seymour "Sy" Brody

Rear Admiral Richard B. Schiff was a lawyer who served the Navy as a Judge Advocate General lawyer and as a judge.

He was born on September 14, 1944, in Joliet, Illinois. His parents were Harriet (Stern) and Leonard L. Schiff. The family was constantly moving around, and he found himself going to many different elementary schools in different states.

He received a B.A. degree from the University of Michigan, in 1966, a JD degree from George Washington University, 1969, and a L.L.M. degree from the University of Virginia, in 1980.

He entered the U. S. Navy in October 1969, as a "direct commission" judge Advocate and with a commission as a Lieutenant. Through the years, he went through the ranks: Lieutenant Commander, 1975, Commander, 1981, Captain, 1988 and when he retired in December 1997, he was promoted to Rear Admiral.
