Lowe \$700 scholarship was awarded to Brian Marsden. Manoharan received the \$500 class of 1953 scholarship, while Browne received \$500 for the Joseph W. Rodgers award. Shenkman received the \$200 Herbert B. Fleisher scholarship. The class of

## DILLON WINS DANNEHOWER AWARD

Molly Dillon, class of 2004, was awarded the Dannehower Award in May. The award is based on the academic, athletic and service merits of high school seniors. The award is given by the Triangle Club of Montgomery County. A five thousand dollar scholarship was presented to Molly who was first in her class and currently attending Yale. Her scholastic honors include three-first place finishes in the Montgomery County Science Fair. She was also a delegate to the PA governor's school of Sciences and was chosen as an Academic All-star by local media and earned Maximum Cum Laude and Summa Cum Laude recognition on the National Latin exam. She was also a National Merit Scholarship Program Commended student. Dillon enjoys sports and other student activities. She played basketball for CHS and was co-captain during her junior and senior years and was selected second-team All League.

She did volunteer work for the Susannah DeLaurentis Walk-a thon for Leukemia and Cystic Fibrosis, and was a lesson assistant with the Pegasus Therapeutic Riding Academy for the Mentally and Physically Challenged. ## HARPER SHINES IN NATIONAL SPOTLIGHT

As a youngster, Laura Harper, class of 2004, did not have much interest in basketball. She had planned to play field hockey when she reached high school. However, she developed an interest in basketball during ninth grade and hasn't looked back since. The Philadelphia Inquirer named her player of the year for Southeastern PA in March, 2004. She was selected as a finalist for the 2004 USA Junior World Championship Qualifying Team. Harper was selected after three days of trials. She was the 2003 and 2004 National Player of the Year. She garnered the MacDonald's All-American Player of the year and was elected captain of the prestigious USA Junior National basketball squad. Her team represented the USA in a tournament in Puerto Rico. The USA team won 121-56. She received the gold medal in the FIBA America's Junior World Championship Qualifying Tournament. The Cheltenham Township commissioners honored her last year with a "Laura Harper day."

Harper became the highest scoring CHS basketball player, boys' or girls' with 2009 points. While a senior, her team earned the distinction of collecting the Suburban I, American Conference and Liberty Division championship for the eighteenth consecutive year. Laura is attending the University of Maryland where she already has received honors. She was the lone-Terrapin to earn a spot on the five-player all-tournament team at the Coors Classic in Boulder, Colorado over Thanksgiving weekend. She averaged 12.5 points, 12.5 rebounds and 3.0 blocks in two games. Harper was recently named ACC Rookie of the Week for her accomplishments.
